ADMISSIONS PROCEDURE & GUIDELINES

1. The candidates should be an Indian National and should satisfy local/non-local status requirements as laid down in G.O. Ms No. 25, dated: 19.3.2004; G.O.Ms.No.108 dated 30-7-2005; GO.Ms. No.66, dated 15-7-2011; G.O.Ms. No.5, dated 2-8-2014; G.O.Ms. No.7, dated 5-8-2014; G.O.Ms. No.33 dated 31-12-2014 and its amendments and G.O. Ms. No. 22, dated 27.07.2019 of Higher Education Department of Telangana State and its amendments.
2. The candidates other than Indian Nationals should satisfy the rules of the Universities concerned.
3. The minimum age of the candidates should be 19 years as on the date of notification (Candidates whose date of Birth up to 30th MARCH, 2003). No maximum age limit.
4. The candidates seeking admission in to :
 1. **Master of Business Administration (MBA):** Should have passed a recognized Bachelor Degree (BA / B.Com/ B.Sc/ BBA / BBM / BCA / BE / B. Tech / B. Pharmacy and any 3 or 4 year degree except Oriental Languages) examinations of minimum three years duration with **at least 50 per cent marks (45 per cent marks in case of reserved categories)** in the qualifying examinations.
 2. The **qualifying degree obtained by the Distance Mode Program/ Open Distance Learning (ODL)** should have recognition by the Joint Committee of UGC, AICTE and DEC/DEB as per UGC Regulations of 2013.
5. The candidates who are appearing for the final year degree examination shall also be eligible to appear for
6. Admission into any college depends on its Recognition/Affiliation by the Statutory Bodies.
7. **Qualifying marks in TSICET is 25 per cent and no minimum marks are prescribed for SC/ST candidates.**

- **Mere qualification in the entrance test does not entitle a candidate to have been admitted into MBA/MCA course unless the candidate:**

1. Appears for Counseling at the notified Centers.
2. Applies in response to the admission notification issued by the authority concerned (for part-time\evening\distance mode).

- Satisfies all the eligibility criteria for admission as stipulated by the authority concerned.

Note: The College reserves the right to cancel the admission of a candidate at any stage if it is detected that the admission is against the rules and regulations of the University.

Filing in the Form

The candidates are required to fill up an application form in their own handwriting giving all their personal and academic details. This will enable proper communication between the college and the students.

Documents for Admission

Candidates should submit their admission forms with the allotment letter either issued by the convener or the management, along with one set of photocopies of the following certificates:

- Transfer Certificate from the Institution where the candidate last studied
- Date of Birth Certificate & SSC Memorandum of Marks
- Migration Certificate by students coming from other than Osmania University
- Bonafide Certificate for classes I to XII
- Income Certificate of the parent/guardian (if necessary)
- Nativity Certificate from the Mandal Revenue Officer (if necessary)
- Caste/Community Certificate from an officer, not below the rank of Mandal Revenue Officer (if necessary)
